**NOTE:** *Each Club in good standing is entitled to nominate one or more members in good standing who continues to demonstrate our Toastmasters values and who meets most of the criteria. The nominee must agree to attend the Fall Awards Ceremony, and the recipient must be present to receive the award. Self-nominations are also welcome.*

*Supporting documentation for each achievement that generates points should include the date of the term and the role performed. Testimonials are not required; however, the nominee may include any additional Toastmasters accomplishments to support the application. The nominee is expected to excel in most of the categories rather than in just a few.*

## **Nomination Process**

1. Consider someone you know who:

- served on the District Executive Committee as:
- District Governor / District Director
- Lieutenant Governor / Program Quality Director / Club Growth Director
- Immediate Past District Governor / Immediate Past District Director
- Division Governor / Division Director
- Area Governor / Area Director
- District Secretary / Administration Manager
- Treasurer / Finance Manager

**NOTE:** *The nominated member has not been in any of the above roles for at least 3 Toastmasters years prior to the date the award is presented. For example, your final completion date for one of the above positions is June 30, 2020. That means you meet eligibility criteria as you have three consecutive years, (i.e., 2020-2021, 2021-2022, 2022-2023).*

- has been a Toastmaster for at least 5 years and continues to be a member in good standing with a Toastmasters club in good standing.
  - has served the District in capacities such as Committee Chair, District Parliamentarian, Workshop Presenter at District Conference, Presenter at Club Officer Training, etc.
  - has served as an International Director
  - has been involved in supporting new Clubs as well as struggling Clubs, as a Club Sponsor, a Club Mentor, or a Club Coach
  - has coordinated and conducted Success/Leadership, Success/Communication, Youth Leadership or Speech Craft workshops
  - promotes Toastmasters in the media – newspapers, blog, radio, TV, other social media or through business.
2. You can nominate yourself if you feel you meet most of the criteria.
  3. Each Club in good standing is entitled to nominate more than one member in good standing that continues to demonstrate our Toastmasters' values and who meets most of the criteria.
  4. Gather information on the individual to be included with the application form.
  5. Nominator must confirm that if the person they are nominating was selected, that person would register for and attend the virtual Fall 'Of The Year' Gala.
  6. Complete the fillable application form. You can add extra pages to supply additional details, if necessary.
  7. Supporting documentation for each achievement that generates points should include the date of the term and the role performed. Testimonials are not required. However, the nominee may include any additional Toastmasters accomplishments to support the application. The nominee is expected to excel in most of the categories rather than in just a few.
  8.   9. Douglas Barclay Award Selection Committee comprises of last year's winner and winners from previous years.
  10. All decisions of the Douglas Barclay Award Selection Committee are final.
